

# National Continued Competency Program & Evidence-based Guidelines

The objective of the National Continued Competency Program (NCCP) is to encourage lifelong learning. Lifelong learning is important to ensure EMS Clinicians are up-to-date on the latest clinical information and competent to deliver quality patient care.

The NCCP has three continuing education requirement areas: National, State/Local, and Individual. The National Registry sets the requirements for the National portion. Effective



for nationally certified EMS clinicians with a certification expiration date of March 31, 2026, or later, the number of credits of continuing education required by content (topic) is listed below under the "PROPOSED CREDITS BASED ON TEST SPECIFICATIONS" chart. There are no longer specific sub-topics that must be addressed under each content (topic).



Additionally, the National Registry is strongly encouraging the incorporation of evidence based guidelines (EBGs) into the national component of the NCCP. As part of this overall initiative, the National Registry partnered with the Prehospital Guidelines Consortium (PGC). The PGC recommendations are to encourage EMS Clinicians and those who instruct them to incorporate evidence-based guidelines into their education and practice. The National Registry will help support this recommendation by providing open access to and/or summaries of the all of the designated guidelines meeting the National Academy of Medicine (NAM) criteria for high-quality guidelines.

The credit changes for the National requirements are captured in the following tables below:

Notes: Complete the total number of credits in each National Component Topic Area. Complete the total required credits based on the National, Local/State, and Individual Component. Local and Individual credits must relate to Emergency Medical Services or EMS patient care. At least 10% of the National Component credits must be pediatric focused content.

### **Questions**

#### **Q-** What is NCCP?

A- The NCCP is a framework designed to encourage lifelong learning measured via continuing education credits requirements that must be fulfilled every two years.

#### **Q-** Why should I care about NCCP?

A- It is important to stay up to date on new advances in healthcare and particularly changes that impact patient care.

#### Q- What are evidence-based guidelines?

**A-** For clinicians, evidence-based guidelines provide a summary of the relevant medical literature and offer assistance in deciding many aspects of clinical practice. They are peer-reviewed documents.



#### Q- Where do I find evidence-based guidelines? Are they required?

A- The PGC EBGs are not required as part of the NCCP, but strongly encouraged at this time. This systematic review will be updated every two years and will be made widely available for all to reference and utilize.

#### Q- What is the timing of these changes?

A- The National Registry has updated the application to reflect the new credit amounts for each topic area for nationally certified clinicians with a certification expiration date of March 31, 2026 and after.

## **Q-** Is the 10% pediatric-related content in addition to the national component credit requirements?

A- No, it's inclusive. For example, an EMT submitting "Pediatric-trauma" and the content is worth two (2) credits. The two (2) credits will apply to the three (3) credits needed for the Trauma topic and it'll satisfy the 10% pediatric content for the entire national component.

## **Q-** Will I continue reporting education on my transcript and categorizing them?

A- Yes, you will continue to report education on your transcript. The main difference is that there will no longer be specific sub-topics that need completed as part of the national component. If you choose to incorporate education related to the EBGs, they can be included as part of your national component.

### **Dates To Know**



Those with a certification expiration date of March 31, 2026, and after will be required to follow the new 2025 NCCP Model.
